Approval of Last Meeting Minutes

<u>Coordinators Report</u>: Absent. Scott Robertson discussed an e-mail that was sent by Kent, regarding the 2016 HMEP Grant Application. The possibility of doing the Commodity Flow Study and asking the County to front the cost and we would reimburse them. The grant is a three year grant cycle. Grayslake had a Haz-Mat response at one of the local hotels. The Grant is due within two weeks from the meeting.

<u>Treasurer's Report</u>: Verbal and written Reports were provided by Dick Johnson. Account balance February 2016 \$15,669.31 Motion by Joe Wieser, seconded by Jim Herring to accept the report. Motion carried.

Public Relations/Education Report

Committee Chairman Jim Herring advised that he has started making speaker contacts this week and sending e-mails. Rich Rapacki is still working on a speaker, and is waiting to hear back from the individual.

By-Laws Committee:

HMEP Grant:

Secretary Jackson gave an update of the 2015 grant reimbursement, and we still have funds left over. The committee was informed that we didn't have any Fire Fighters to request sponsorship to attend the 28th Annual Midwest Hazardous Materials Response Conference. We could have sent two attendees.

Also discussed was what should we do with the partial funding for the Commodity Flow Study. This matter was discussed among those present. The funding couldn't be used to sponsor grant proposal from the local fire departments. This topic was discussed at length and it was final decided to de-obligate the commodity flow study funding \$9,031.32. Half of the allowable expenses didn't meet our current needs. Motion made by Dick Johnson and seconded by Scott Robertson, Motion Carried.

After the discussing on this matter it was motioned by Scott Robertson and seconded by Joe Wieser to return \$5031.32 and to retain \$4000.00 for the use of Lake County Haz-Mat Team. 2015 Grant.

FFY 2016 HMEP Grant Application the committee discussed the new process of the 3-year grant period. After the discussion of the application and process it was decided that we should ask for \$60,000.00 for the Commodity Flow Study and \$5,000.00 for a Haz-Mat Transportation Training Exercise. Motion by LEPC Chairperson Cynthia Tomusiak and seconded by Scott Robertson.

Website Committee: Nothing new, request to add a Link to Chemical Facility Anti-Terrorism Standards (CFATS) Covered Chemical Facilities.

Scott Robertson advised that the Chemical Annex and Plan is still ongoing.
