• Requests for Personal Protective Equipment (PPE) continued but are now on an as needed basis, with LCEMA totaling 4.9 million items distributed to date.

• On 2/10/2021 EMA staff provide mutual aid to Gurnee and Zion Police for a missing 22-year old male from Highwood. Over 12 organizations throughout Northern Illinois were able to assist and were able to cover over 300 acres of land.

<u>Incident Reporting</u>: Chairperson Robertson advised that we received a few reports of Tank Removals and a Spill from a vehicle accident. We are receiving Tier II reports.
